Vecinos Elections

Cholla Security



Security in Cholla Bay continues to be an issue for homeowners in Cholla Bay. There has been many burglaries reported in our community. Even more disturbing, some of these burglaries have occurred when the homes were occupied. For all of 2017, there was little police presence in Cholla and the police station fell into disrepair. This presented the opportunity for thieves to operate in Cholla with little deterrent. Vecinos President, Mike Dugan, met with Peñasco Presidente (mayor) and the chief of police to voice our concerns. The Peñasco authorities committed to a police presence 24/7 in

Cholla. The HOA committed funds to repair and police station and provide vehicles for the officers. The officers have been patrolling our community as a result. Many Cholla residents felt this effort was a step in the right direction, but want more, consistent protection. A proposal was presented at the February Board meeting to provide private security in Cholla. The Board felt there was too many unclear details in the proposal as presented to approve the plan. A committee of Board members and community members was formed to examine and clarify the proposal for private security. Obviously, any proposal for private security will require a financial commitment from the Vecinos membership and a resulting increase in annual dues. The committee has already met once and is working diligently to prepare a private security option to be included in the 2018-19 annual budget. There are many advantages of private security in Cholla, including local control and professional management. However, the committee is looking carefully at all aspects of private security, especially the unintended consequences resulting from the approval of the security option. Your Vecinos Board encourages every homeowner to protect their property in every way possible, including a monitored alarm system.
